One-year guarantee<sup>4</sup>

Credits an established fixed interest rate guaranteed for the first contract year; afterwards, renewal rates are declared annually.

One-year participation rate<sup>5</sup>

At the end of the indexed term, the beginning and ending values of the BlackRock Dynamic Allocation Index are compared to calculate the percentage change. If the change is positive, the account is credited the percentage change multiplied by a participation rate. If the result is zero or negative, your account is protected from loss but no interest will be credited. 1 Year BlackRock Dynamic Allocation Participation Plus includes an annual fee of 1% for a higher participation rate. The fee is based on the amount allocated to the account, and is deducted at the beginning of the indexed term.

At the end of the one-year indexed term, the beginning and ending values of the Fidelity AIM Dividend Index are compared to calculate the percentage change. If the change is positive, your account is credited the percentage change multiplied by the participation rate. If the result is zero or negative, your account is protected from loss but no interest will be credited.

One-year participation rate<sup>5</sup>

At the end of the one-year indexed term, the beginning and ending values of the S&P 500 Daily Risk Control 5% Index or the S&P 500 Daily Risk Control 10% Index are compared to calculate the percentage change. If the change is positive, your account is credited the full percentage change minus a spread. If the result is zero, negative, or less than the spread, your account is protected from loss but no interest will be credited.

One-year specified rate<sup>5</sup>

At the end of the one-year indexed term, if the S&P 500 Index has a positive change or remains flat, your account is credited a specified rate. If it's negative, your account is protected from loss but no interest will be credited.

At the end of the one-year indexed term, the beginning and ending values of the S&P 500 Index are compared to calculate the percentage change. If the change is positive, your account is credited the full percentage change up to an interest cap. If the result is zero or negative, your account is protected from loss but no interest will be credited.

One-year participation rate<sup>5</sup>

At the end of the one-year indexed term, the beginning and ending values of the S&P 500 Index are compared to calculate the percentage change. If the change is positive, your account is credited the percentage change multiplied by the participation rate. If the result is zero or negative, your account is protected from loss but no interest will be credited.

**Minimum accumulated contract value at the end of surrender charge period:** 100% of premium accumulated at 0.10% annual growth (credited daily). This calculation is also used to determine the Guaranteed Minimum Nonsurrender Value, which is only available upon death or annuitization.
